01. Market Commentary

DSEX ended in red for the week decreasing by 14.64 points [0.28%] compared to the previous week. It stands at 5237.32 points.

Index have gone downward for four consecutive weeks as investors see no catalyst for a positive market momentum in the recent scenario. However, this week the index volatility was quite low compared to few previous weeks' scenario. Some investors took gains from quick rallying stocks while others took positions in specific scrips which have undergone significant correction. Some investors remained watchful due to concerns relating to the national budget.

Investor participation increased this week as reflected by increase in average daily turnover by around 30% and the average daily turnover managed to cross the BDT 500 Crore level. Investors' trades in this week mostly focused on Pharmaceuticals, Food & Allied and Textile scrips. The Tannery sector topped the gainer list while the Mutual Funds sector topped the losers list.

Market capitalization stands at USD 54.8 Billion*. *(USD 1 = BDT 117.95 as on June 06, 2024).



02. Related Market Policies

- 1. BB issued a circular in which it stated that effective from Jun 02, 2024 all related operations concerning government treasury securities will be conducted via. the newly developed system Financial Market Infrastructure (FMI) module instead of the existing system Market Infrastructure (MI) module. This has been decided to correspond the auctioning and trading of government securities as per international standards, easing and improving secondary trading of government securities and for providing liquidity facilities to the banks and finance companies (NBFIs).
- 2. BB issued a circular in which it stated that all scheduled banks are required to remeasure/revalue i.e. Mark-to-Market their Held for Trading (HFT) treasury bonds on the basis of secondary market yields rather than primary market yields except for treasury bills.
- 3. BB issued guidelines on licensing, operation and regulation of Credit Bureau. Credit Bureau will conduct credit scoring of individuals to analyze their loan repayment capability and right to avail loans to establish a modern credit risk assessment system.
- 4. BB issued guidelines for issuing prepaid instruments by non-payment system entities to lessen financial and operational risk of Prepaid Instruments (Vouchers, Gift Cards etc.) issued by merchants of marketplaces and to protect clients' interests.
- 5. IDRA issued a circular directing the life and non-life insurance companies to comply with several regulations regarding training of insurance agents in order to develop human capital for the insurance sector.




- 6. Finance Minister AH Mahmood Ali presented the 53rd budget of the fiscal year 2024-25 on 6th June 2024. Among the issues contained in the budget, the major ones relating to the capital market are as follows:
 - a. Corporate tax rates for non-publicly traded companies have been reduced by 2.5% narrowing the tax gap between listed and non-listed companies to 5% for listed companies offering shares of more than 10% via. IPO and to 2.5% for listed companies offering shares of 10% or less than 10% via. IPO.
 - b. Capital gains exceeding BDT 50 Lakh received by an individual taxpayer from transfer of shares or units of a listed company or fund shall be taxed at 15%.
 - c. TDS on capital gains from shares or units of listed companies or funds by sponsor-director shareholders and placement shareholders have been increased to 10% from the existing 5% rate.




